Chris Piskor of the Wexford County Sheriff's Dept. that the officer was conducting a criminal investigation, did knowingly and willfully make a statement or statements to the office that he or she knew was false or misleading regarding the following material fact or facts relating to the investigation to wit: Cortney Bartholomew had Bradley Bartholomew strike Rebecca Park in the head causing a seizure and then took her body away, and the officer was conducting a criminal investigation for 1st Degree Murder; contrary to MCL 750.479c(2)(d). [750.479C2D]

FELONY: 4 years and/or \$5,000.00.

#### **COUNT 3: FALSE REPORT OF A FELONY**

did intentionally make a false report of the commission of a felony, Felonious Assault to Det/Sgt. Chris Piskor of the Wexford County Sheriff's Dept., knowing that the report was false; contrary to MCL 750.411a(1)(b). [750.411A1B]

FELONY: 4 Years and/or \$2,000.00
